MSA NORTHERN REGIONS CHAMPIONSHIP CIRCULAR 70 OF 2016 – CIRCUIT MOTORCYCLE

The following addition to the 2016 Northern Regions Circuit Motorcycle Championship Circular 3 of 2016 is implemented with immediate effect:

The KTM 390 Cup Senior **club** class has been added as an additional class to the Northern Regions Circuit Motorcycle Championship series. The following rules will apply to the class:

1. All riders shall be in possession of a club/regional or national competition licence valid for circuit Motorcycle racing in 2016.
2. The aim of the class is to declare a KTM 390 Senior **Club** champion for 2016.
3. Riders will be eligible to compete from 01 January of the year in which they turn 30 years old.
4. No age restrictions will be placed on female competitors.
5. The following modifications will be allowed to be made to the motorcycle
 - 5.1 Any exhaust slip on with standard header pipe.
 - 5.2 Any rear sets, triple clamps or bars
 - 5.3 No motor modifications will be allowed. Standard 41-43 hp and 34nm torque
 - 5.4 No suspension modifications outside of oil and air gap.
 - 5.5 No changes to the fuelling system or ECU
 - 5.6 No changes to the factory standard braking system, except brake pads
 - 5.7 No changes to the gearing 45 rear 15 front, unless specified prior to the event
 - 5.8 No modifications to the air box or the inlet system.
6. The tyres allowed will be Metzeler, Pirelli factory issue or the Pirelli SC1.
